## Disclosure Regarding Financial Assistance

- Awards of financial assistance granted by the Foundation will be dispersed on a case-by-case basis. The satisfaction of minimum eligibility standards does not guarantee grant approval for financial assistance. The Carly Stowell Foundation does not discriminate based on race, color, religion, national origin, sex, sexual orientation, or political affiliation.
- The Foundation reserves the right to condition any award or grant and at any time to modify the amount in terms of any financial assistance awarded or to terminate such financial assistance upon a change of either the grantee's or the Foundation's circumstances or the discovery of new information relevant to such financial assistance or this application.
